


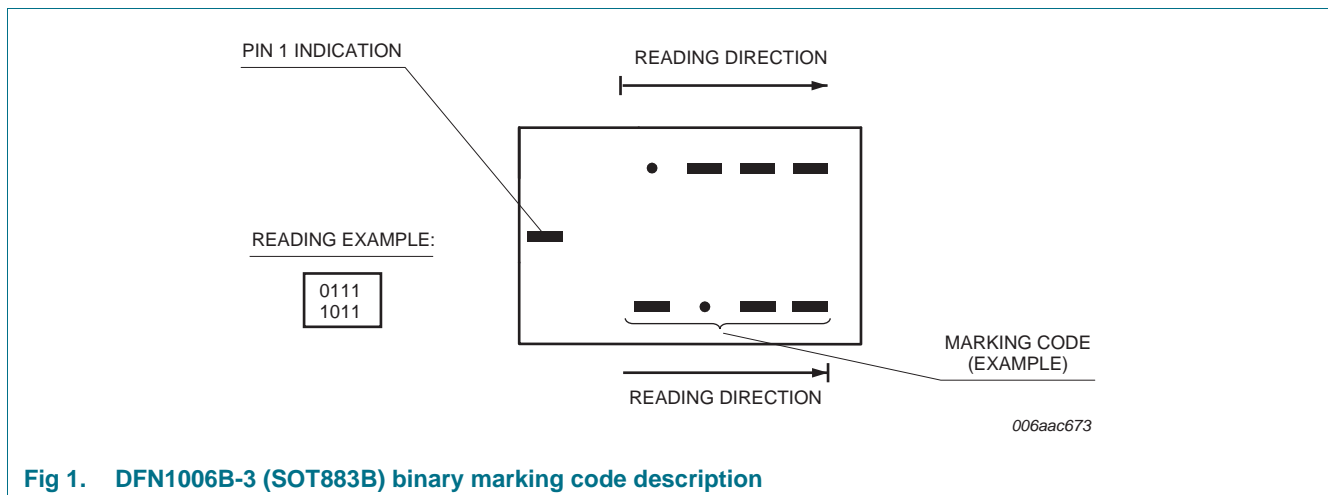


Fig 1. DFN1006B-3 (SOT883B) binary marking code description

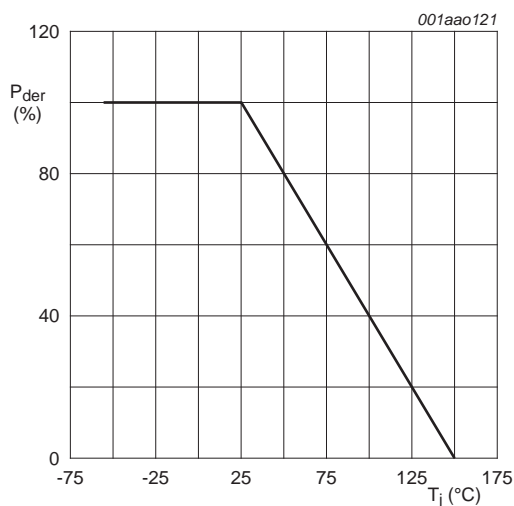

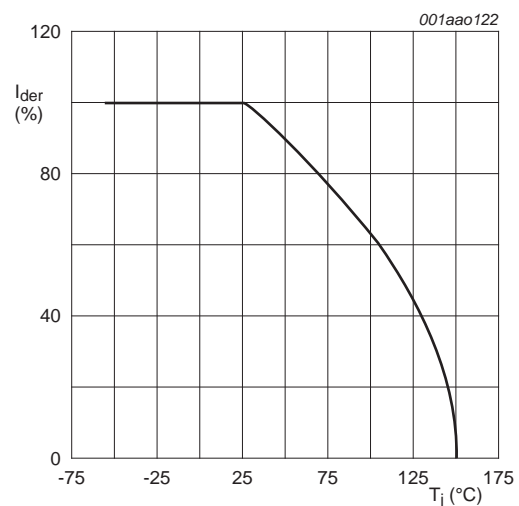

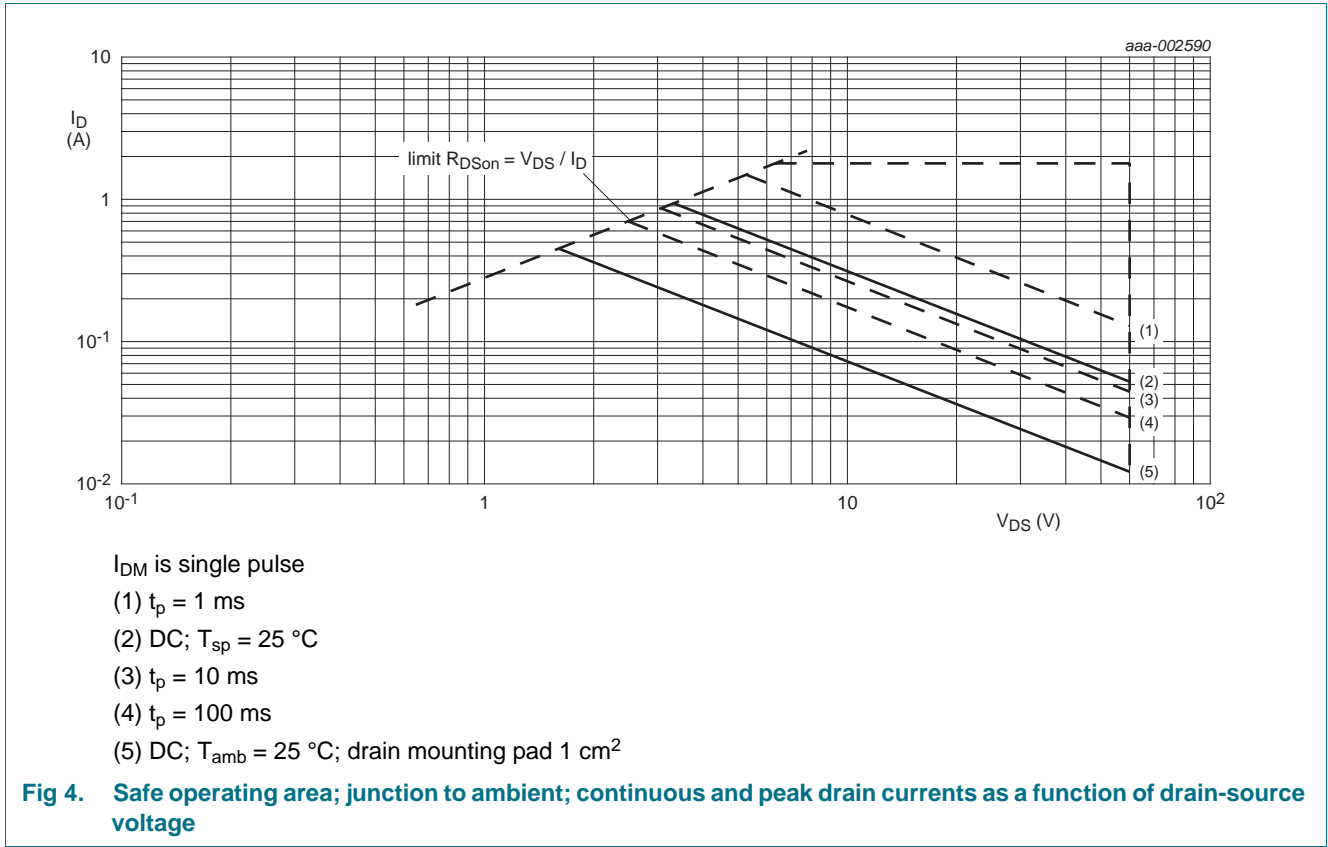

**Fig 3. Normalized continuous drain current as a function of junction temperature**



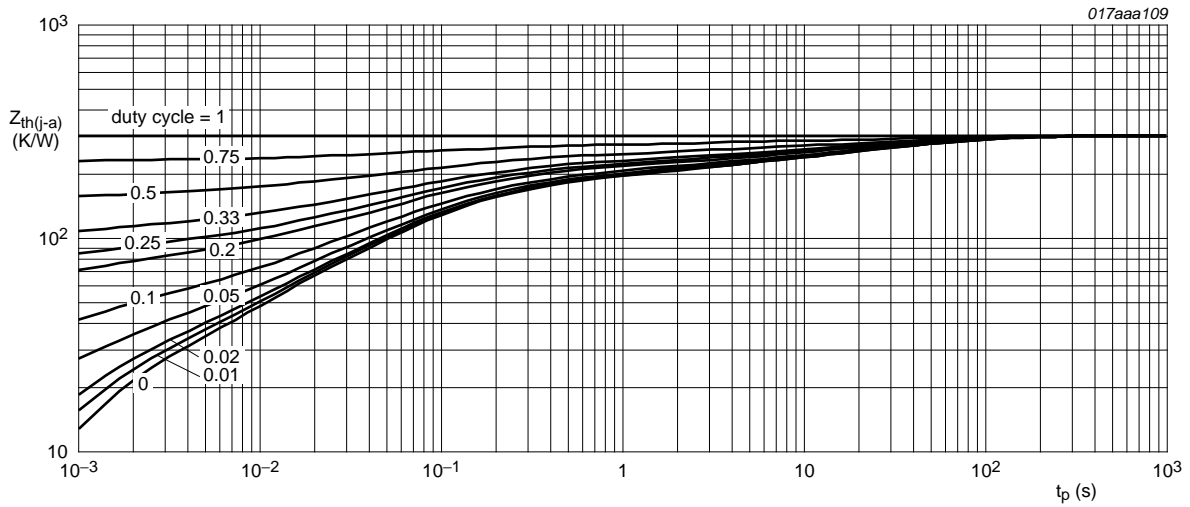

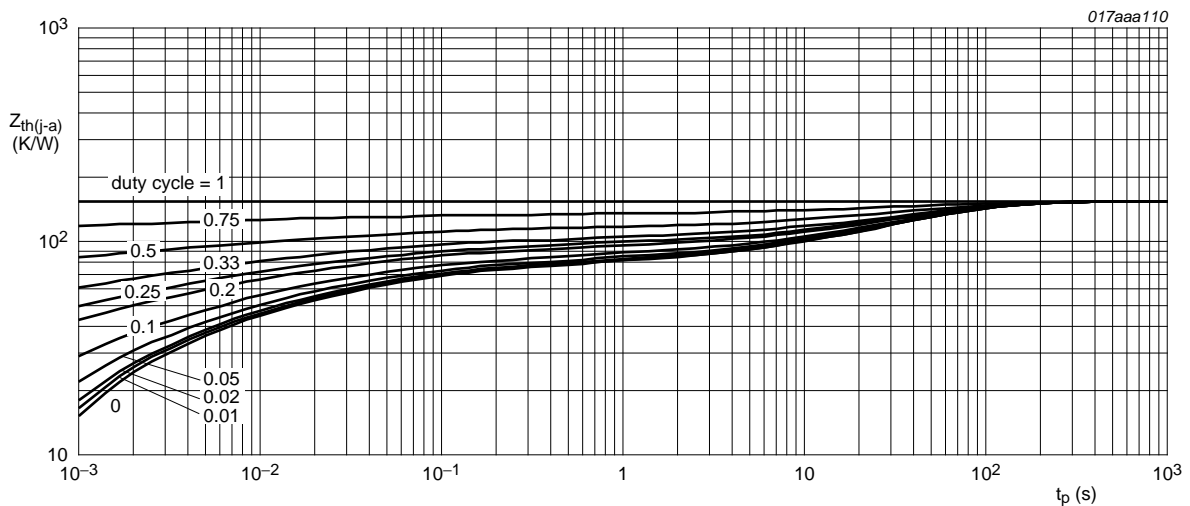

Fig 5. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values



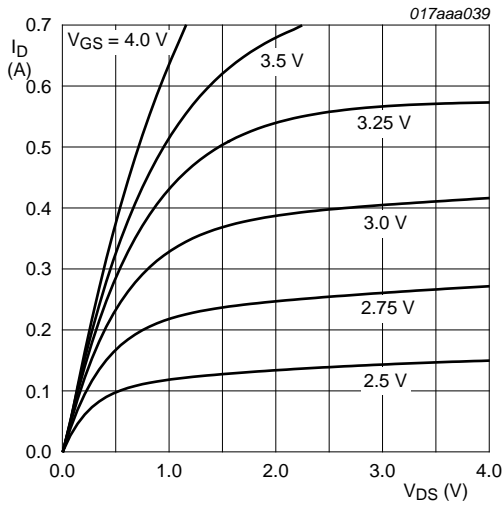
FR4 PCB, mounting pad for drain 1 cm<sup>2</sup>

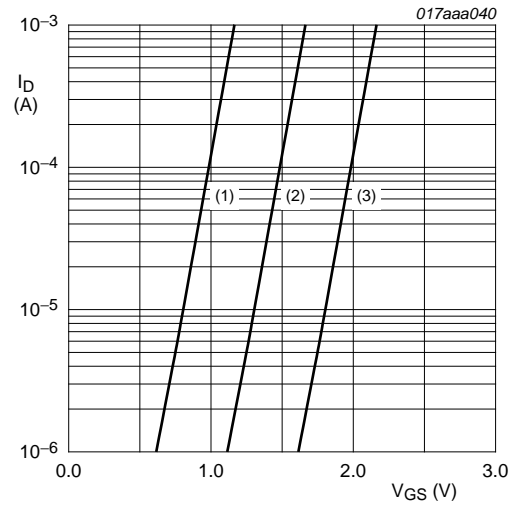

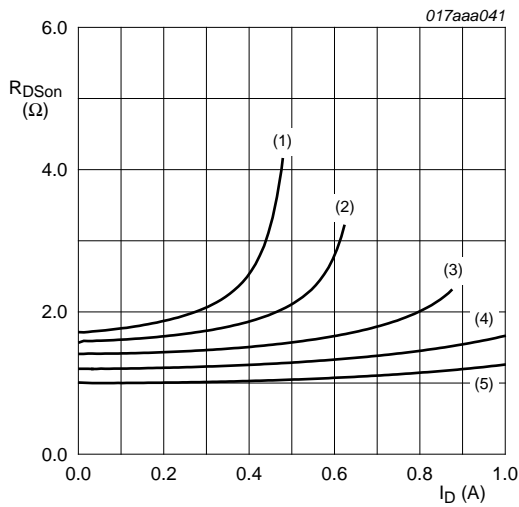
Fig 7. Output characteristics: drain current as a function of drain-source voltage; typical values

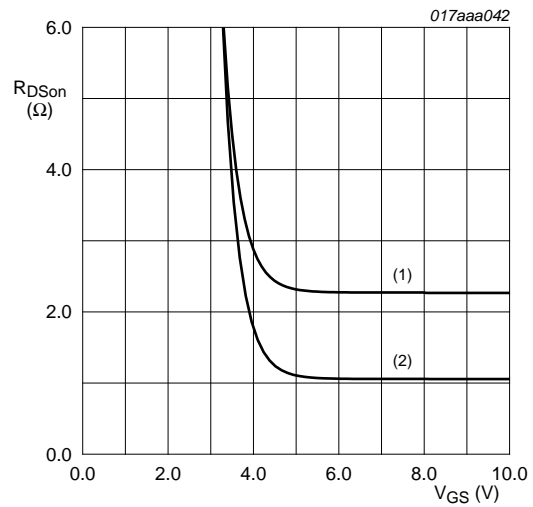
Fig 8. Sub-threshold drain current as a function of gate-source voltage

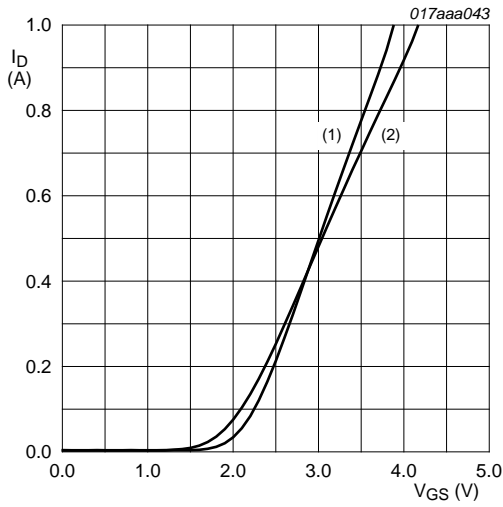
Fig 9. Drain-source on-state resistance as a function of drain current; typical values

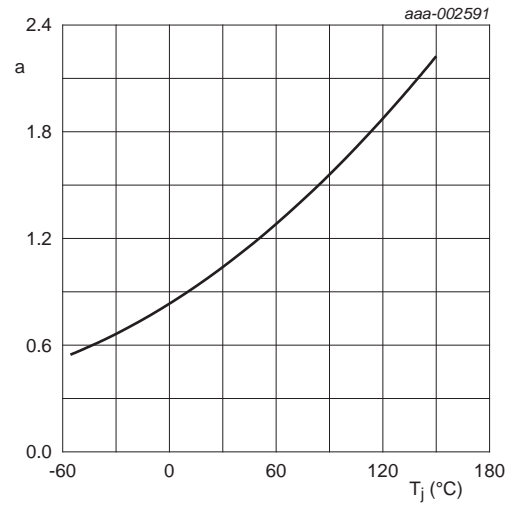

Fig 10. Drain-source on-state resistance as a function of gate-source voltage; typical values



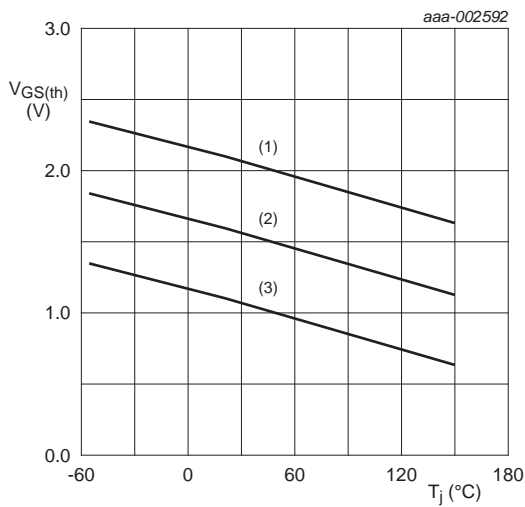

**Fig 11. Transfer characteristics: drain current as a function of gate-source voltage; typical values**



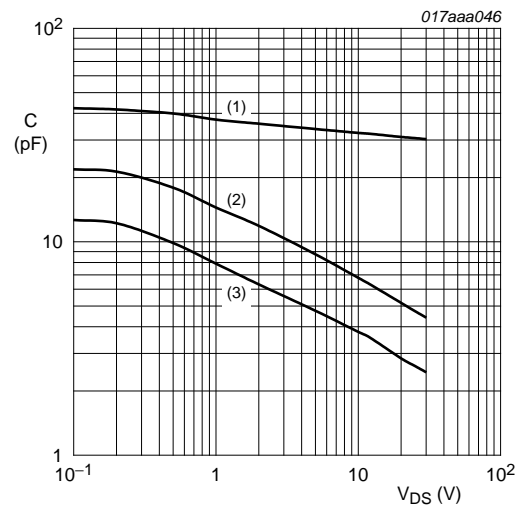

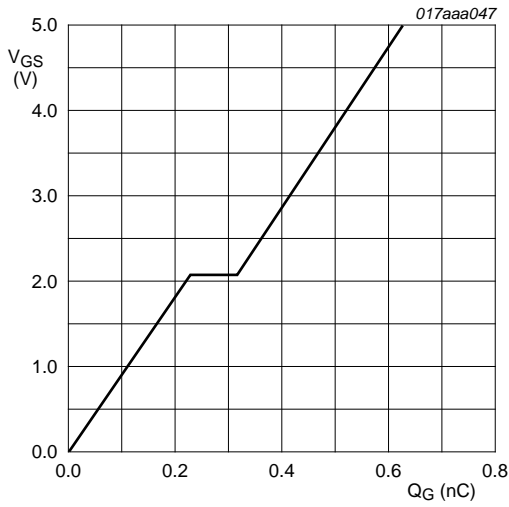
**Fig 13. Gate-source threshold voltage as a function of junction temperature**

Fig 15. Gate-source voltage as a function of gate charge; typical values

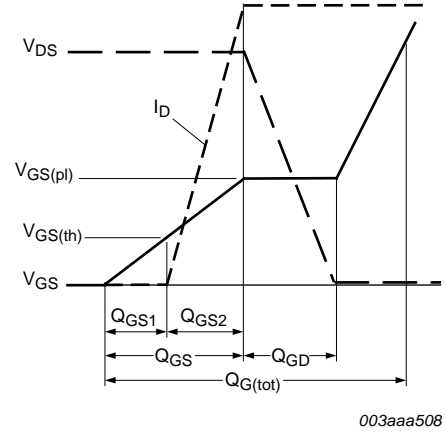
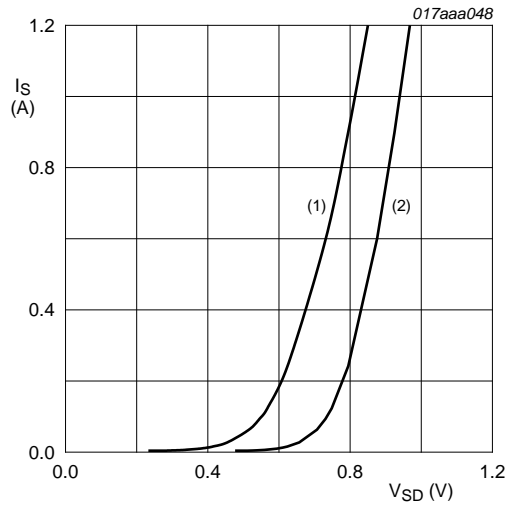


Fig 16. Gate charge waveform definitions

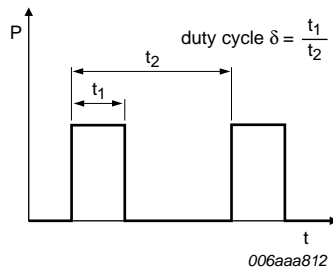


Fig 18. Duty cycle definition

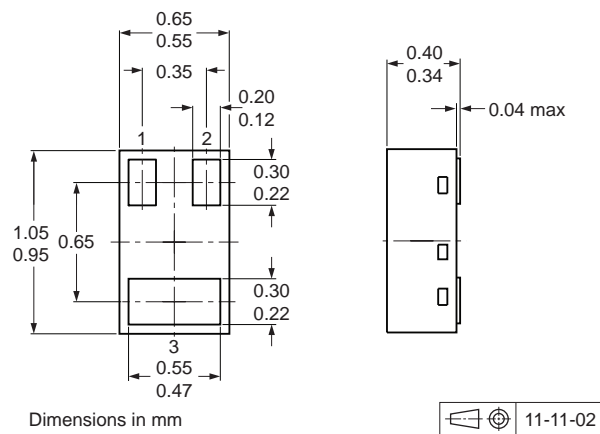


Fig 19. Package outline SOT883B (DFN1006B-3)

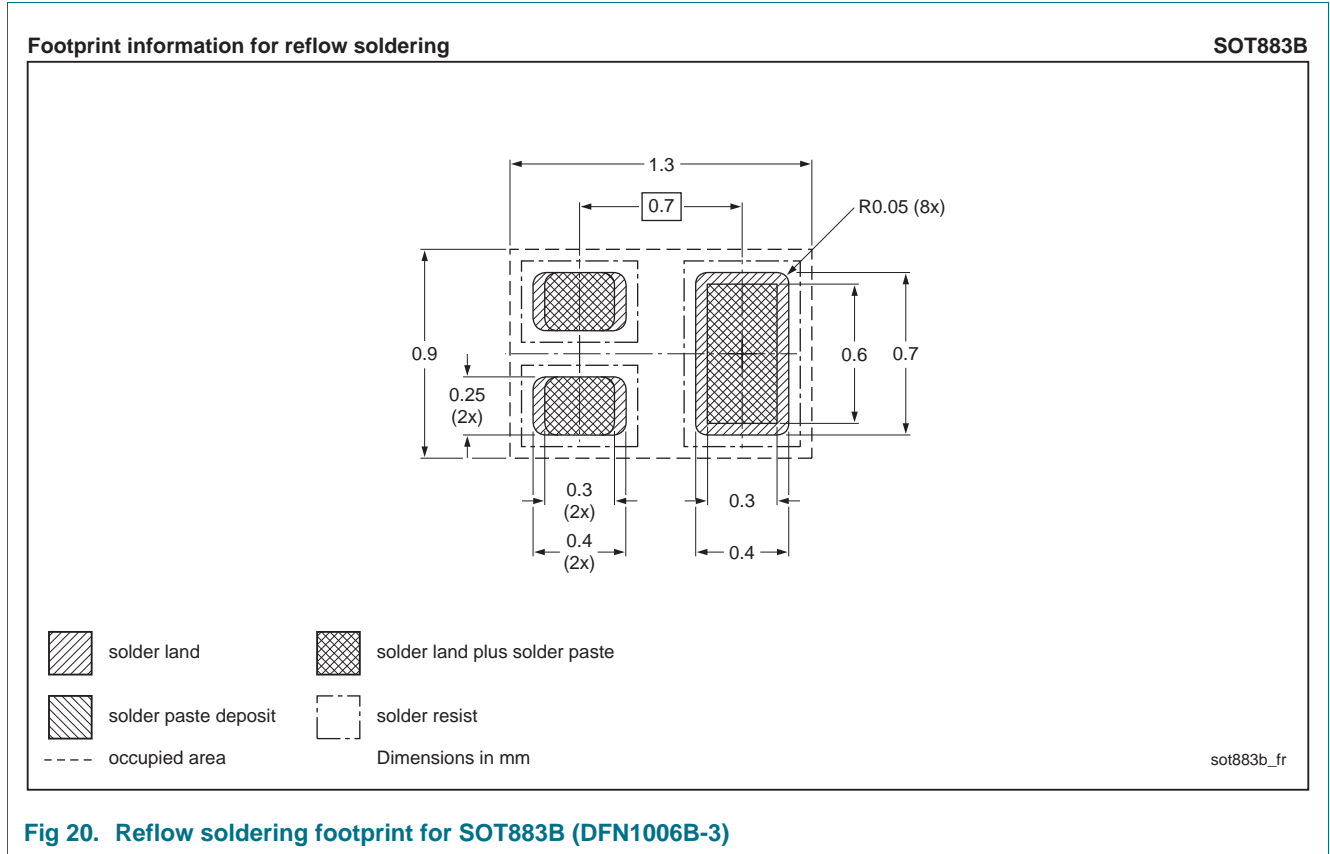


Fig 20. Reflow soldering footprint for SOT883B (DFN1006B-3)
