Description

This -20-V, 64-m Ω , P-Channel FemtoFET™ MOSFET is designed and optimized to minimize the footprint in many handheld and mobile applications. This technology is capable of replacing standard small signal MOSFETs while providing a substantial reduction in footprint size. The integrated $10-k\Omega$ clamp resistor (R_C) allows the gate voltage (V_{GS}) to be operated above the maximum internal gate oxide value of -6 V depending on duty cycle. The gate leakage (I_{GSS}) through the diode increases as V_{GS} is increased above -6 V.








Figure 11. Maximum Drain Current vs Temperature
