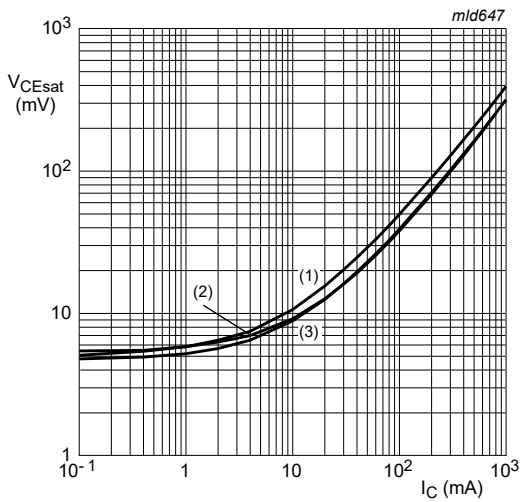

**Fig. 1. DC current gain as a function of collector current; typical values**



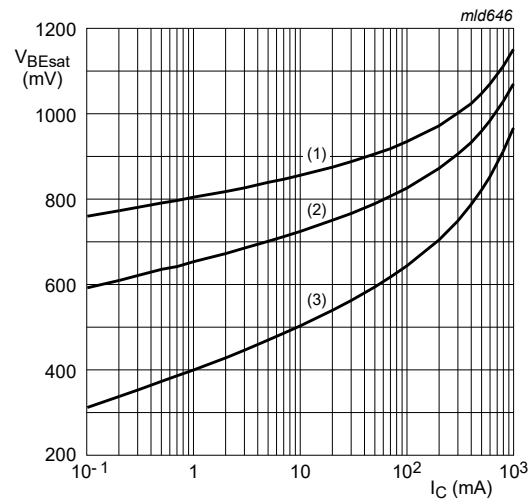

**Fig. 2. Base-emitter voltage as a function of collector current; typical values.**



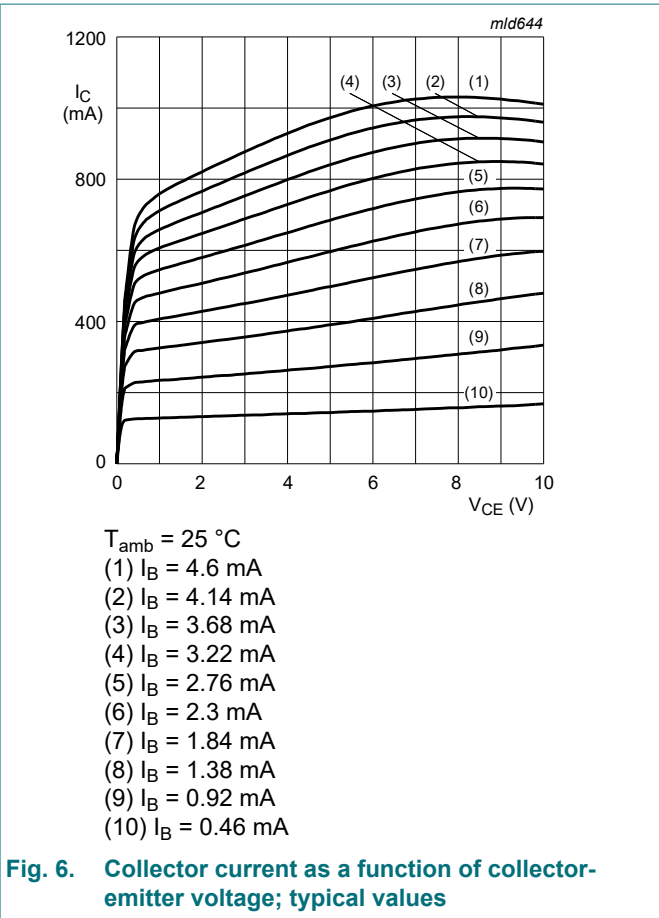
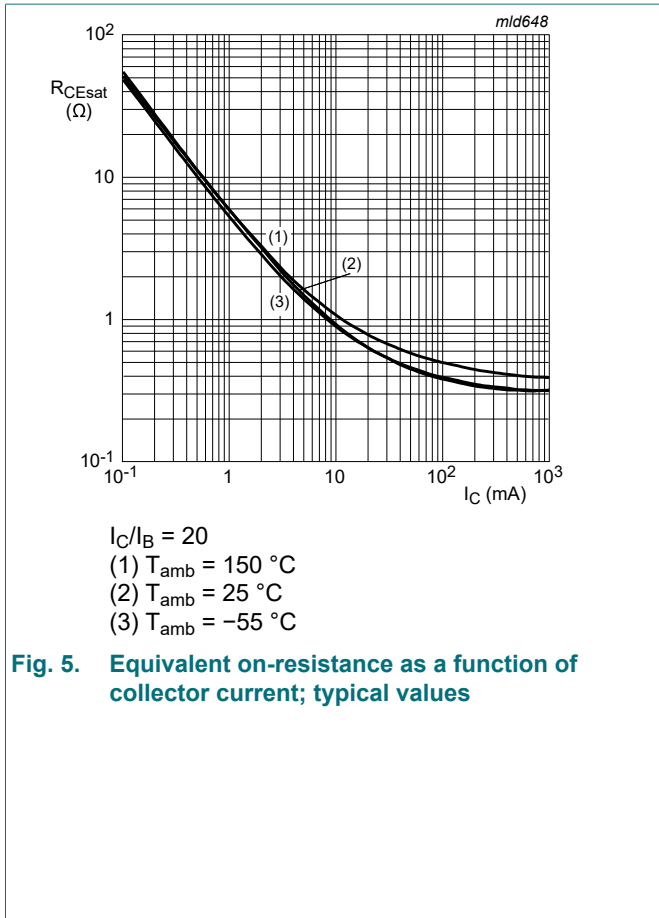

**Fig. 3. Collector-emitter saturation voltage as a function of collector current; typical values.**

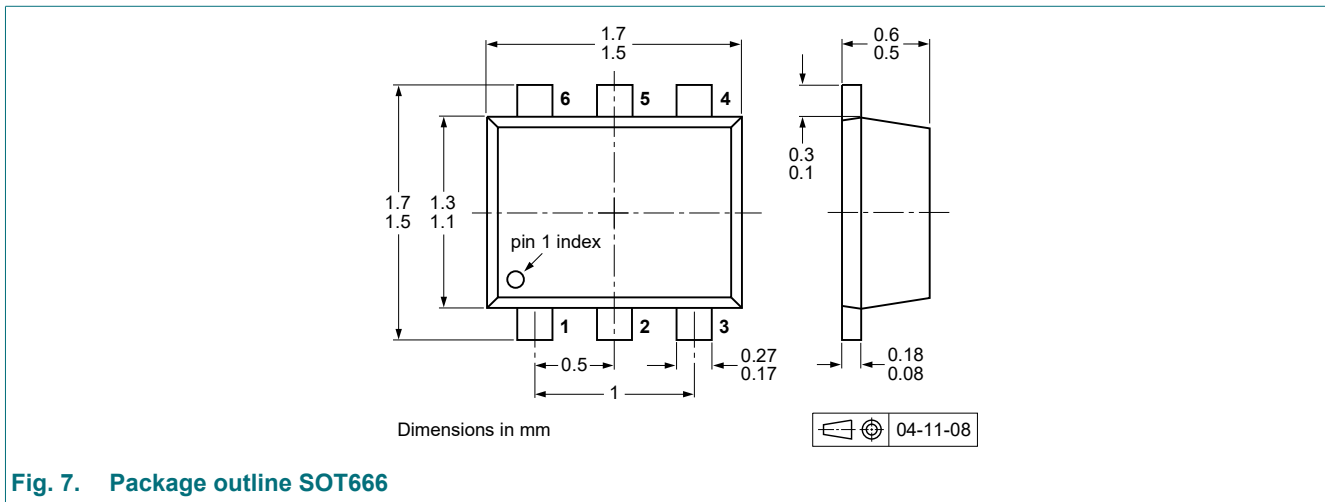

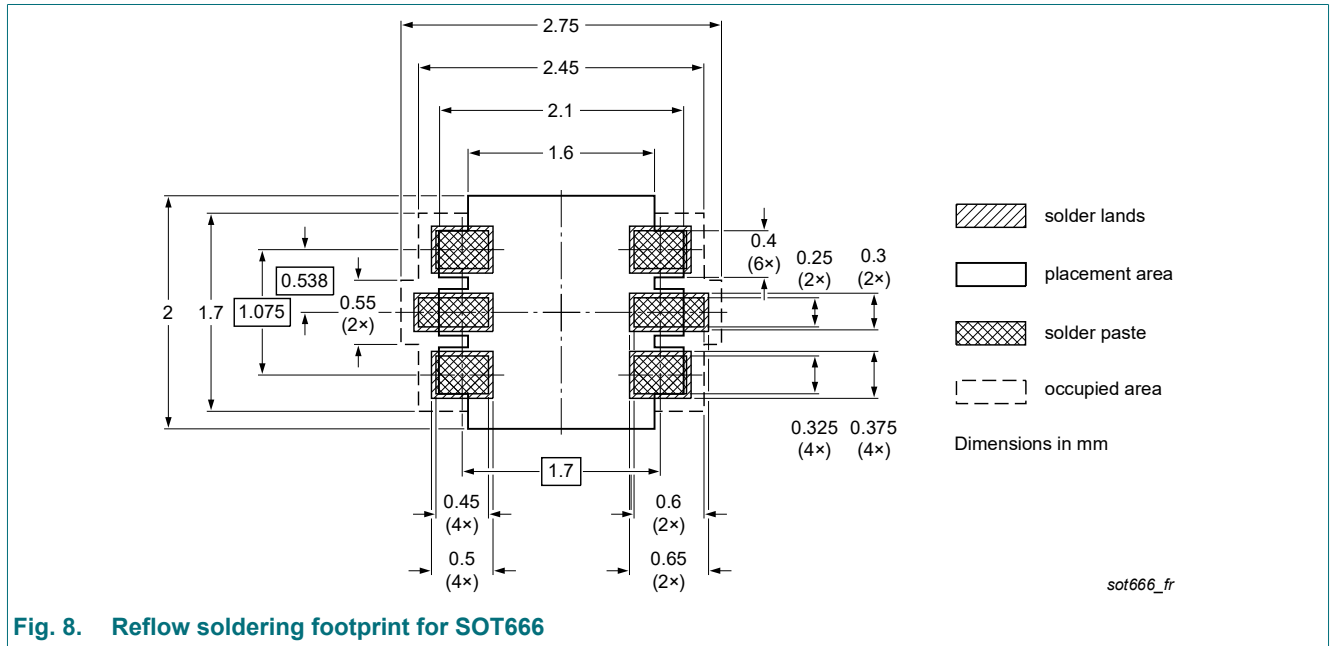


Fig. 8. Reflow soldering footprint for SOT666
