## 3 Description

The LMZ12001EXT SIMPLE SWITCHER® power module is an easy-to-use step-down DC-DC solution capable of driving up to 1-A load with exceptional power conversion efficiency, line and load regulation, and output accuracy. The LMZ12001EXT is available in an innovative package that enhances thermal performance and allows for hand or machine soldering.


The LMZ12001EXT can accept an input voltage rail between 4.5 V and 20 V, and can deliver an adjustable and highly accurate output voltage as low as 0.8 V. The LMZ12001EXT only requires three external resistors and four external capacitors to complete the power solution. The LMZ12001EXT is a reliable and robust design with the following protection features: thermal shutdown, undervoltage lockout, output overvoltage protection, short circuit protection, output current limit, and the device allows start-up into a prebiased output. A single resistor adjusts the switching frequency up to 1 MHz.






## 7 Detailed Description

#### 7.1 Overview

The LMZ12001EXT power module is an easy-to-use step-down DC-DC solution capable of driving up to 1-A load with exceptional power conversion efficiency, line and load regulation, and output accuracy.

## 7.3 Feature Description

#### 7.3.1 COT Control Circuit Overview

Constant ON-Time control is based on a comparator and an ON-time one-shot, with the output voltage feedback compared with an internal 0.8-V reference. If the feedback voltage is below the reference, the main MOSFET is turned on for a fixed ON-time determined by a programming resistor  $R_{ON}$ .  $R_{ON}$  is connected to  $V_{IN}$  such that ON-time is reduced with increasing input supply voltage. Following this ON-time, the main MOSFET remains off for a minimum of 260 ns. If the voltage on the feedback pin falls below the reference level again the ON-time cycle is repeated. Regulation is achieved in this manner.

#### 7.3.2 Output Overvoltage Comparator

The voltage at FB is compared to a 0.92-V internal reference. If FB rises above 0.92 V the ON-time is immediately terminated. This condition is known as overvoltage protection (OVP). It can occur if the input voltage is increased very suddenly or if the output load is decreased very suddenly. Once OVP is activated, the top MOSFET ON-times will be inhibited until the condition clears. Additionally, the synchronous MOSFET will remain on until inductor current falls to zero.

#### 7.3.3 Current Limit

Current limit detection is carried out during the OFF-time by monitoring the current in the synchronous MOSFET. Referring to the *Functional Block Diagram*, when the top MOSFET is turned off, the inductor current flows through the load, the PGND pin and the internal synchronous MOSFET. If this current exceeds 1.5 A (typical) the current limit comparator disables the start of the next ON-time period. The next switching cycle will occur only if the FB input is less than 0.8 V and the inductor current has decreased below 1.5 A. Inductor current is monitored during the period of time the synchronous MOSFET is conducting. So long as inductor current exceeds 1.5 A, further ON-time intervals for the top MOSFET will not occur. Switching frequency is lower during current limit due to the longer OFF-time.

#### NOTE

Current limit is dependent on both duty cycle and temperature as illustrated in the graphs in the *Typical Characteristics* sections.

## **Feature Description (continued)**

#### 7.3.4 Thermal Protection

The junction temperature of the LMZ12001EXT must not be allowed to exceed its maximum ratings. Thermal protection is implemented by an internal Thermal Shutdown circuit which activates at 165°C (typical) causing the device to enter a low power standby state. In this state the main MOSFET remains off causing  $V_O$  to fall, and additionally the CSS capacitor is discharged to ground. Thermal protection helps prevent catastrophic failures for accidental device overheating. When the junction temperature falls back below 145°C (typ Hyst = 20 °C) the SS pin is released,  $V_O$  rises smoothly, and normal operation resumes.

Applications requiring maximum output current especially those at high input voltage may require application derating at elevated temperatures.

#### 7.3.5 Zero Coil Current Detection

The current of the lower (synchronous) MOSFET is monitored by a zero coil current detection circuit which inhibits the synchronous MOSFET when its current reaches zero until the next ON-time. This circuit enables the DCM operating mode, which improves efficiency at light loads.

#### 7.3.6 Prebiased Start-Up

The LMZ12001EXT will properly start up into a prebiased output. This start-up situation is common in multiple rail logic applications where current paths may exist between different power rails during the start-up sequence. The following scope capture shows proper behavior during this event.




Figure 35. Prebiased Start-Up

## 7.4 Device Functional Modes

#### 7.4.1 Discontinuous Conduction and Continuous Conduction Modes

At light load the regulator will operate in discontinuous conduction mode (DCM). With load currents above the critical conduction point, it will operate in continuous conduction mode (CCM). When operating in DCM the switching cycle begins at zero amps inductor current; increases up to a peak value, and then recedes back to zero before the end of the OFF-time. Note that during the period of time that inductor current is zero, all load current is supplied by the output capacitor. The next ON-time period starts when the voltage on the at the FB pin falls below the internal reference. The switching frequency is lower in DCM and varies more with load current as compared to CCM. Conversion efficiency in DCM is maintained since conduction and switching losses are reduced with the smaller load and lower switching frequency.



## 8 Application and Implementation

## 8.1 Application Information

The LMZ12001EXT is a step-down DC-to-DC power module. It is typically used to convert a higher DC voltage to a lower DC voltage with a maximum output current of 1 A. The following design procedure can be used to select components for the LMZ12001EXT. Alternately, the WEBENCH software may be used to generate complete designs. When generating a design, the WEBENCH software utilizes iterative design procedure and accesses comprehensive databases of components. Please go to www.ti.com for more details

## 8.2 Typical Application




Figure 36. Evaluation Board Schematic Diagram

#### 8.2.1 Design Requirements

For this example the following application parameters exist.

- V<sub>IN</sub> Range = Up to 20 V
- V<sub>OUT</sub> = 0.8 V to 6 V
- I<sub>OUT</sub> = 1 A

### 8.2.2 Detailed Design Procedure

The LMZ12001EXT is fully supported by WEBENCH and offers the following: component selection, electrical and thermal simulations as well as the build-it board for a reduction in design time. The following list of steps can be used to manually design the LMZ12001EXT application.



## Typical Application (continued)

- 1. Select minimum operating V<sub>IN</sub> with enable divider resistors
- 2. Program V<sub>O</sub> with divider resistor selection
- 3. Program turnon time with soft-start capacitor selection
- Select C<sub>O</sub>
- 5. Select C<sub>IN</sub>
- 6. Set operating frequency with RON

## 8.2.2.1 Enable Divider, $R_{ENT}$ and $R_{ENB}$ Selection

The enable input provides a precise 1.18-V band-gap rising threshold to allow direct logic drive or connection to a voltage divider from a higher enable voltage such as Vin. The enable input also incorporates 90 mV (typical) of hysteresis resulting in a falling threshold of 1.09 V. The maximum recommended voltage into the EN pin is 6.5 V. For applications where the midpoint of the enable divider exceeds 6.5 V, a small Zener diode can be added to limit this voltage.

The function of this resistive divider is to allow the designer to choose an input voltage below which the circuit will be disabled. This implements the feature of programmable undervoltage lockout. This is often used in battery-powered systems to prevent deep discharge of the system battery. It is also useful in system designs for sequencing of output rails or to prevent early turnon of the supply as the main input voltage rail rises at power-up. Applying the enable divider to the main input rail is often done in the case of higher input voltage systems where a lower boundary of operation must be established. In the case of sequencing supplies, the divider is connected to a rail that becomes active earlier in the power-up cycle than the LMZ12001EXT output rail. The two resistors must be chosen based on the following ratio:

$$R_{ENT} / R_{ENB} = (V_{IN \ UVLO} / 1.18 \ V) - 1$$
 (1)

The LMZ12001EXT demonstration and evaluation boards use 11.8 k $\Omega$  for R<sub>ENB</sub> and 32.4 k $\Omega$  for R<sub>ENT</sub> resulting in a rising UVLO of 4.5 V. This divider presents 5.34 V to the EN input when the divider input is raised to 20 V.

### 8.2.2.2 Output Voltage Selection

Output voltage is determined by a divider of two resistors connected between  $V_O$  and ground. The midpoint of the divider is connected to the FB input. The voltage at FB is compared to a 0.8-V internal reference. In normal operation an ON-time cycle is initiated when the voltage on the FB pin falls below 0.8 V. The main MOSFET ON-time cycle causes the output voltage to rise and the voltage at the FB to exceed 0.8 V. As long as the voltage at FB is above 0.8 V, ON-time cycles will not occur.

The regulated output voltage determined by the external divider resistors RFBT and RFBB is:

$$V_{O} = 0.8 \text{ V} \times (1 + R_{FBT} / R_{FBB})$$
 (2)

Rearranging terms; the ratio of the feedback resistors for a desired output voltage is:

$$R_{EBT} / R_{EBB} = (V_O / 0.8 \text{ V}) - 1$$
 (3)

These resistors must be chosen from values in the range of 1.0 k $\Omega$  to 10.0 k $\Omega$ .

For  $V_O = 0.8$  V the FB pin can be connected to the output directly so long as an output preload resistor remains that draws more than 20  $\mu$ A. Converter operation requires this minimum load to create a small inductor ripple current and maintain proper regulation when no load is present.

A feed-forward capacitor is placed in parallel with R<sub>FBT</sub> to improve load step transient response. Its value is usually determined experimentally by load stepping between DCM and CCM conduction modes and adjusting for best transient response and minimum output ripple.

Table 1 lists the values for R<sub>FRT</sub>, R<sub>FRB</sub>, C<sub>FF</sub> and R<sub>ON</sub>.

#### 8.2.2.3 Soft-Start Capacitor Selection

Programmable soft-start permits the regulator to slowly ramp to its steady-state operating point after being enabled, thereby reducing current inrush from the input supply and slowing the output voltage rise-time to prevent overshoot.

Upon turnon, after all UVLO conditions have been passed, an internal 8-µA current source begins charging the external soft-start capacitor. The soft-start time duration to reach steady state operation is given by the formula:

$$t_{SS} = V_{REF} \times C_{SS} / Iss = 0.8 \text{ V} \times C_{SS} / 8 \mu A$$
 (4)

This equation can be rearranged as follows:

$$C_{SS} = t_{SS} \times 8 \,\mu\text{A} / 0.8 \,\text{V}$$
 (5)

Use of a 0.022-µF capacitor results in 2.2-ms soft-start interval which is recommended as a minimum value.

As the soft-start input exceeds 0.8 V the output of the power stage will be in regulation. The soft-start capacitor continues charging until it reaches approximately 3.8 V on the SS pin. Voltage levels between 0.8 V and 3.8 V have no effect on other circuit operation. Note that the following conditions will reset the soft-start capacitor by discharging the SS input to ground with an internal 200-µA current sink.

- The enable input being pulled low
- Thermal shutdown condition
- Overcurrent fault
- Internal V<sub>CC</sub> UVLO (Approx 4-V input to V<sub>IN</sub>)

### 8.2.2.4 C<sub>O</sub> Selection

None of the required  $C_O$  output capacitance is contained within the module. At a minimum, the output capacitor must meet the worst case minimum ripple current rating of  $0.5 \times I_{LR~P-P}$ , as calculated in Equation 16 below. Beyond that, additional capacitance will reduce output ripple so long as the ESR is low enough to permit it. A minimum value of 10  $\mu$ F is generally required. Experimentation will be required if attempting to operate with a minimum value. Ceramic capacitors or other low ESR types are recommended. See AN-2024 SNVA422 for more detail.

The following equation provides a good first pass approximation of C<sub>O</sub> for load transient requirements:

$$C_O \ge I_{STEP} \times V_{EB} \times L \times V_{IN} / (4 \times V_O \times (V_{IN} - V_O) \times V_{OLIT-TRAN})$$
(6)

Solvina:

 $C_{O} \ge 1 \text{ A} \times 0.8 \text{ V} \times 10 \text{ } \mu\text{H} \times 12 \text{ V} / (4 \times 3.3 \text{ V} \times (12 \text{ V} - 3.3 \text{ V}) \times 33 \text{ mV}) \ge 25 \text{ } \mu\text{F}$ 

The LMZ12001EXT demonstration and evaluation boards are populated with a 100-µF 6.3-V X5R output capacitor. Locations for other output capacitors are provided.



### 8.2.2.5 C<sub>IN</sub> Selection

The LMZ12001EXT module contains an internal 0.47-µF input ceramic capacitor. Additional input capacitance is required external to the module to handle the input ripple current of the application. This input capacitance must be located in very close proximity to the module. Input capacitor selection is generally directed to satisfy the input ripple current requirements rather than by capacitance value. Worst case input ripple current rating is dictated by the equation:

$$I(C_{IN(RMS)}) \approx 1/2 \times I_O \times \sqrt{(D/1-D)}$$

where

• 
$$D \cong V_O / V_{IN}$$
 (7)

As a point of reference, the worst case ripple current will occur when the module is presented with full load current and when  $V_{IN} = 2 \times V_{O}$ .

Recommended minimum input capacitance is 10-µF X7R ceramic with a voltage rating at least 25% higher than the maximum applied input voltage for the application. TI recommends to pay attention to the voltage and temperature deratings of the capacitor selected.

#### **NOTE**

Ripple current rating of ceramic capacitors may be missing from the capacitor data sheet and you may have to contact the capacitor manufacturer for this rating.

If the system design requires a certain minimum value of input ripple voltage  $\Delta V_{IN}$  be maintained then the following equation may be used.

$$C_{IN} \ge I_O \times D \times (1 - D) / f_{SW-CCM} \times \Delta V_{IN}$$
 (8)

If  $\Delta V_{IN}$  is 1% of  $V_{IN}$  for a 20-V input to 3.3-V output application this equals 200 mV and  $f_{SW}$  = 400 kHz.

$$C_{IN} \ge 1A \times 3.3 \text{ V} / 20 \text{ V} \times (1 - 3.3 \text{ V} / 20 \text{ V}) / (400000 \times 0.200 \text{ V}) \ge 1.7 \text{ } \mu\text{F}$$

Additional bulk capacitance with higher ESR may be required to damp any resonant effects of the input capacitance and parasitic inductance of the incoming supply lines.

#### 8.2.2.6 R<sub>ON</sub> Resistor Selection

Many designs will begin with a desired switching frequency in mind. For that purpose the following equation can be used.

$$f_{SW/CCM} \approx V_0 / (1.3 \times 10^{-10} \times R_{ON})$$
 (9)

This can be rearranged as

$$R_{ON} \approx V_O / (1.3 \times 10^{-10} \times f_{SW(CCM)})$$
 (10)

The selection of RON and  $f_{SW(CCM)}$  must be confined by limitations in the ON-time and OFF-time for the COT control section.

The ON-time of the LMZ12001EXT timer is determined by the resistor  $R_{ON}$  and the input voltage  $V_{IN}$ . It is calculated as follows:

$$t_{ON} = (1.3 \times 10^{-10} \times R_{ON}) / V_{IN}$$
 (11)

The inverse relationship of  $t_{ON}$  and  $V_{IN}$  gives a nearly constant switching frequency as  $V_{IN}$  is varied.  $R_{ON}$  must be selected such that the ON-time at maximum  $V_{IN}$  is greater than 150 ns. The ON-timer has a limiter to ensure a minimum of 150 ns for  $t_{ON}$ . This limits the maximum operating frequency, which is governed by the following equation:

$$f_{SW(MAX)} = V_O / (V_{IN(MAX)} \times 150 \text{ ns})$$
(12)

This equation can be used to select  $R_{ON}$  if a certain operating frequency is desired so long as the minimum ON-time of 150 ns is observed. The limit for  $R_{ON}$  can be calculated as follows:

$$R_{ON} \ge V_{IN(MAX)} \times 150 \text{ ns} / (1.3 \times 10^{-10})$$
 (13)

If  $R_{ON}$  calculated in Equation 10 is less than the minimum value determined in Equation 13 a lower frequency must be selected. Alternatively,  $V_{IN(MAX)}$  can also be limited in order to keep the frequency unchanged.

Additionally, consider the minimum OFF-time of 260 ns limits the maximum duty ratio. Larger  $R_{ON}$  (lower  $F_{SW}$ ) must be selected in any application requiring large duty ratio.




#### 8.2.2.7 Discontinuous Conduction and Continuous Conduction Modes Selection

Operating frequency in DCM can be calculated as follows:

$$f_{SW(DCM)} \approx V_O \times (V_{IN} - 1) \times 10 \ \mu H \times 1.18 \times 10^{20} \times I_O / (V_{IN} - V_O) \times R_{ON}^2$$
 (14)

In CCM, current flows through the inductor through the entire switching cycle and never falls to zero during the OFF-time. The switching frequency remains relatively constant with load current and line voltage variations. The CCM operating frequency can be calculated using Equation 9 above.

Figure 37 is a comparison pair of waveforms of the showing both CCM (upper) and DCM operating modes.





The approximate formula for determining the DCM/CCM boundary is as follows:

$$I_{DCB} \cong V_O \times (V_{IN} - V_O) / (2 \times 10 \ \mu\text{H} \times f_{SW(CCM)} \times V_{IN})$$
(15)

Figure 38 is a typical waveform showing the boundary condition.

The inductor internal to the module is 10  $\mu$ H. This value was chosen as a good balance between low and high input voltage applications. The main parameter affected by the inductor is the amplitude of the inductor ripple current ( $I_{LR}$ ).  $I_{LR}$  can be calculated with:

$$I_{LR~P-P} = V_O \times (V_{IN} - V_O) / (10 \mu H \times f_{SW} \times V_{IN})$$

where

•  $V_{IN}$  is the maximum input voltage and  $f_{SW}$  is determined from Equation 9. (16)

If the output current  $I_O$  is determined by assuming that  $I_O = I_L$ , the higher and lower peak of  $I_{LR}$  can be determined. Be aware that the lower peak of  $I_{LR}$  must be positive if CCM operation is required.




Figure 41. Radiated Emissions (EN 55022 Class B) from Evaluation Board

## 9 Power Supply Recommendations

The LMZ12001EXT device is designed to operate from an input voltage supply range between 4.5 V and 20 V. This input supply must be well regulated and able to withstand maximum input current and maintain a stable voltage. The resistance of the input supply rail must be low enough that an input current transient does not cause a high enough drop at the LMZ12001EXT supply voltage that can cause a false UVLO fault triggering and system reset. If the input supply is more than a few inches from the LMZ12001EXT, additional bulk capacitance may be required in addition to the ceramic bypass capacitors. The amount of bulk capacitance is not critical, but a 47-μF or 100-μF electrolytic capacitor is a typical choice.

## 10 Layout

## 10.1 Layout Guidelines

PCB layout is an important part of DC-DC converter design. Poor board layout can disrupt the performance of a DC-DC converter and surrounding circuitry by contributing to EMI, ground bounce and resistive voltage drop in the traces. These can send erroneous signals to the DC-DC converter resulting in poor regulation or instability. Good layout can be implemented by following a few simple design rules.

### 1. Minimize area of switched current loops.

From an EMI reduction standpoint, it is imperative to minimize the high di/dt current paths during PCB layout. The high current loops that do not overlap have high di/dt content that will cause observable high frequency noise on the output pin if the input capacitor  $C_{\text{IN1}}$  is placed a distance away for the LMZ12001. Therefore physically place  $C_{\text{IN1}}$  as close as possible to the LMZ12001EXT VIN and GND exposed pad. This will minimize the high di/dt area and reduce radiated EMI. Additionally, grounding for both the input and output capacitor must consist of a localized top side plane that connects to the GND exposed pad (EP).

#### 2. Have a single point ground.

The ground connections for the feedback, soft-start, and enable components must be routed to the GND pin of the device. This prevents any switched or load currents from flowing in the analog ground traces. If not properly handled, poor grounding can result in degraded load regulation or erratic output voltage ripple behavior. Provide the single point ground connection from pin 4 to EP.

#### 3. Minimize trace length to the FB pin.

Both feedback resistors,  $R_{FBT}$  and  $R_{FBB}$ , and the feed forward capacitor  $C_{FF}$ , must be located close to the FB pin. Since the FB node is high impedance, maintain the copper area as small as possible. The trace are from  $R_{FBT}$ ,  $R_{FBB}$ , and  $C_{FF}$  must be routed away from the body of the LMZ12001EXT to minimize noise.

#### 4. Make input and output bus connections as wide as possible.

This reduces any voltage drops on the input or output of the converter and maximizes efficiency. To optimize voltage accuracy at the load, ensure that a separate feedback voltage sense trace is made to the load. Doing so will correct for voltage drops and provide optimum output accuracy.

#### 5. Provide adequate device heat-sinking.

Use an array of heat-sinking vias to connect the exposed pad to the ground plane on the bottom PCB layer. If the PCB has a plurality of copper layers, these thermal vias can also be employed to make connection to inner layer heat-spreading ground planes. For best results use a  $6 \times 6$  via array with a minimum via diameter of 8 mils thermal vias spaced 59 mils (1.5 mm). Ensure enough copper area is used for heat-sinking to keep the junction temperature below 125°C.




Figure 42. Critical Current Loops to Minimize




Figure 43. PCB Layout Guide




Figure 44. Top View of Evaluation PCB




Figure 45. Bottom View of Evaluation PCB

## 10.3 Power Dissipation and Thermal Considerations

For the design case of  $V_{IN}$  = 12 V,  $V_O$  = 1.8 V,  $I_O$  = 1 A,  $T_{AMB(MAX)}$  = 85°C , and  $T_{JUNCTION}$  = 125°C, the device must see a thermal resistance from case to ambient of:

$$R_{\theta CA} < (T_{J-MAX} - T_{AMB(MAX)}) / P_{IC-LOSS} - R_{\theta JC}$$

$$(17)$$

Given the typical thermal resistance from junction to case to be  $1.9^{\circ}\text{C/W}$ . Use the  $85^{\circ}\text{C}$  power dissipation curves in the *Typical Characteristics* section to estimate the  $P_{\text{IC-LOSS}}$  for the application being designed. In this application it is 0.4W

$$R_{9CA} < (125 - 85) / 0.4 W - 1.9 = 98.1$$
 (18)

To reach  $R_{\theta CA} = 98.1$ , the PCB is required to dissipate heat effectively. With no airflow and no external heat, a good estimate of the required board area covered by 1 oz. copper on both the top and bottom metal layers is:

Board Area\_cm<sup>2</sup> = 
$$500^{\circ}$$
C × cm<sup>2</sup>/W / R<sub>e,IC</sub> (19)

As a result, approximately 5 square cm of 1-oz. copper on top and bottom layers is required for the PCB design. The PCB copper heat sink must be connected to the exposed pad. Approximately thirty six, 8 mils thermal vias spaced 59 mils (1.5 mm) apart must connect the top copper to the bottom copper. For an example of a high thermal performance PCB layout, refer to the Evaluation Board application note AN–2024 SNVA422. For more information on thermal design see AN–2020 and AN–2026.

## 10.4 Power Module SMT Guidelines

The recommendations below are for a standard module surface mount assembly

- · Land Pattern Follow the PCB land pattern with either soldermask defined or non-soldermask defined pads
- Stencil Aperture
  - For the exposed die attach pad (DAP), adjust the stencil for approximately 80% coverage of the PCB land pattern
  - For all other I/O pads use a 1:1 ratio between the aperture and the land pattern recommendation
- Solder Paste Use a standard SAC Alloy such as SAC 305, type 3 or higher
- Stencil Thickness 0.125 to 0.15 mm
- Reflow Refer to solder paste supplier recommendation and optimized per board size and density
- Refer to Design Summary LMZ1xxx and LMZ2xxx Power Modules Family (SNAA214) for reflow information.
- Maximum number of reflows allowed is one




Figure 46. Sample Reflow Profile

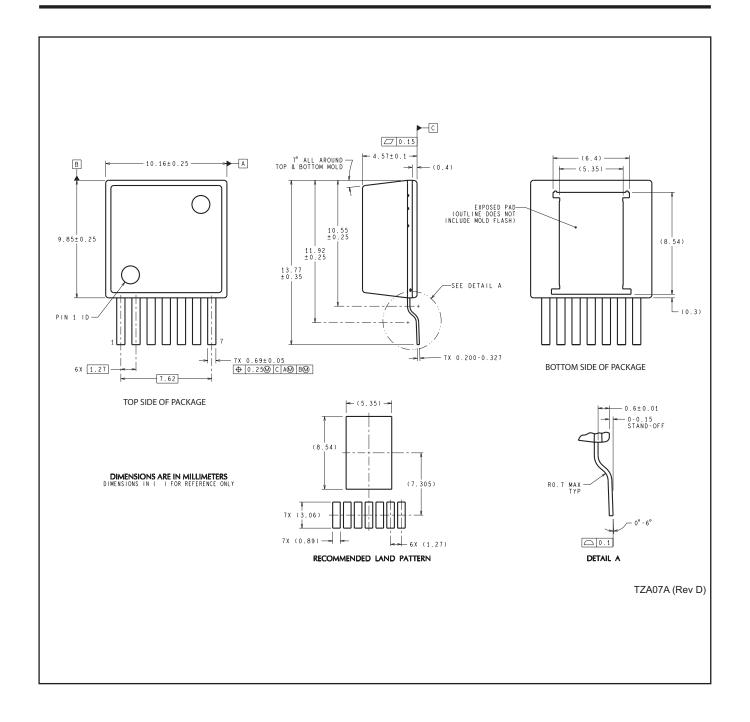
