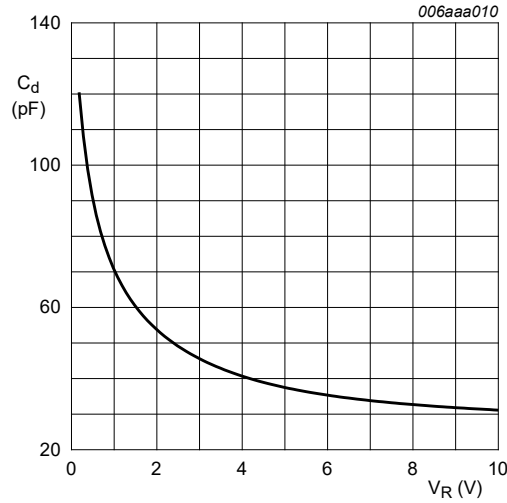

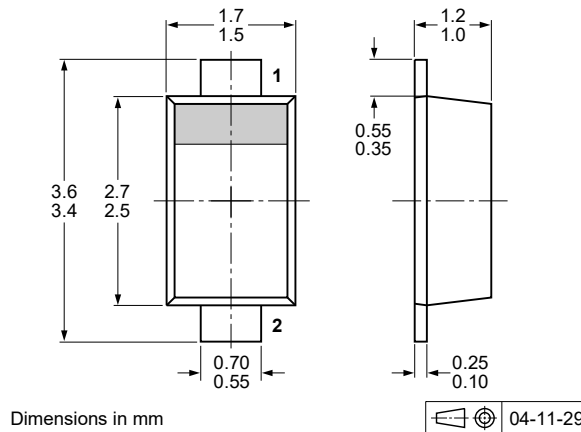


Fig. 4. Package outline SOD123F

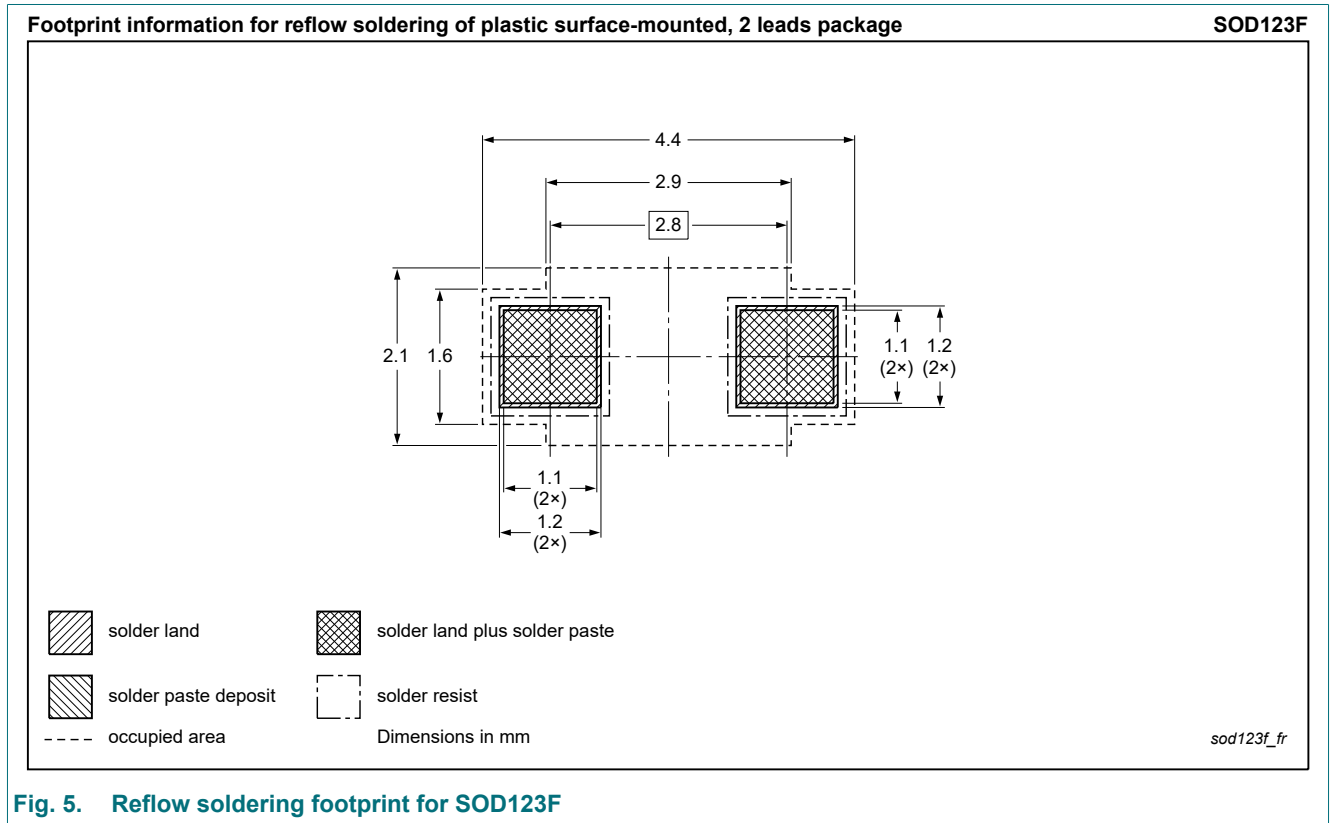


Fig. 5. Reflow soldering footprint for SOD123F
